The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a blue Alfa Romero SUV (QGXT49) that was stopped for suspicion of DUI after I observed its driving pattern. It swerved outside of its lane and almost struck a curb, drifted within its lane, touched the lane markers, and failed to stay within its lane when it made a left turn. During observations, he displayed indicators of impairment which included having red glassy eyes, slurred speech, and the distinct odor of an alcoholic beverage on his breath. He advised he drank two beers 3-4 hours earlier in the evening. He displayed additional indicators of impairment during the SFSTs and was arrested for DUI. He was taken to CBT where he took the breath test. He provided breath samples of .184/.189. The defendant's identity was verified using his state of Georgia driver's license.
