 On the above listed date and time, at the above listed location, I responded to assist Sergeant J Humphrey (ABN 190005) on a suspicious vehicle call for service. Upon my arrival, I observed the defendant to be in actual physical control of a black Chevrolet Blazer bearing FL tag LTTV40. I observed the defendant asleep behind the wheel, with the vehicle on and the vehicle's gear shifter in the park position. Upon contact with the defendant, I observed several signs of impairment to include, bloodshot watery glassy eyes, slurred speech, he was unsteady on his feet and the odor of an alcoholic beverage on his breath. Standardized Field Sobriety Exercises were conducted and impairment was observed. The defendant was arrested for DUI. After a proper 20 minute observation period, the defendant provided two lawful breath samples (0.125 / 0.134 BrAC). The defendant admitted to drinking several alcoholic beverages prior to driving. The defendant was identified by his Florida driver's license
