The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was operating a 2019 Volkswagen Jetta bearing MA Tag 543RC2. The defendant was observed by the witness traveling west on E 14th Ave and failing to stop for the stop sign. The witness observed the defendant strike a 2016 Honda Civic, being operated by the victim, that was traveling south on N Av Republic de Cuba, resulting in both vehicles becoming completely disabled (approx. \$15,000 in damage). While speaking with the defendant, I noticed signs of impairment. I observed the defendant's eyes were bloodshot and glossy. He was swaying as he stood. While speaking with the defendant, I detected the distinct odor of an alcoholic beverage emitting from his breath. Post Miranda Warning, the defendant admitted to drinking two "Crown and Coke" at TGIF around 1300 hours. The defendant agreed to do Field Sobriety Exercises. The defendant showed signs of impairment and based on the totality of circumstances, he was arrested for DUI. The defendant provided breath samples of .141 and .141 BrAC.

The defendant was positively identified via Massachusetts Driver's License.
