The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 06/16/2022 at approximately 0342 hours, the driver/defendant was operating her white 2017 Hyundai SUV with Florida tag IHSR20 southbound on Dale Mabry Hwy N approaching the round-about for MacDill Air Force Base. The defendant failed to navigate the round-about, ran off of the roadway, and struck several street signs owned by the Air Force base causing approximately \$1,000 in damages. The driver/defendant was placed in actual physical control of the vehicle during the traffic crash by Air Force personnel. TPD Ofc. C. Wilson made contact with the driver/defendant, observed indicators of impairment, and requested a DUI investigation be conducted. I responded to the scene and made contact with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, had the odor of an alcoholic beverage coming from her breath, and had a noticeable sway while standing. During a post-Miranda statement she admitted to driving the vehicle during the traffic crash and drinking several "high noons" prior to driving. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. The defendant refused to submit to the requested breath testing after being read Implied Consent. She was positively identified via DHSMV photograph.
