The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 08/03/2022, near the intersection of North Dale Mabry Highway and West Waters Avenue the defendant was observed by Deputy J. Hollowell ABN: 261373 operating a black 2012 Honda Civic bearing Florida tag INVM76 with an assigned VIN of 19XFB2F9XCE008401 driver's side headlight out. Upon Deputy Hollowell's contact with the defendant, he observed multiple indicators of impairment. While in direct contact with the defendant, I observed her to have bloodshot watery/glassy eyes, she had slurred speech, she was slightly unsteady on her feet, and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant refused to participate in the field sobriety exercises. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she refused to provide two lawful breath samples. As a result, she was read Implied Consent and she continued to refuse by stating "No." I further identified the defendant via her DAVID photograph.
