The center through lane was not occupied and the driver could have safely changed lanes. The roads were also wet as it had been raining all night As the driver approached Sample Rd, I activated my emergency lights in order to conduct a traffic stop The driver continued southbound and eventually came to a slow and sudden stop inside the parking lot of Township Plaza next to Veteran's Park As I approached the driver's side door, I immediately was able to smell a very strong odor of an alcoholic beverage coming from inside the vehicle I asked the driver for his driver's license, registration and insurance card The driver gave me all of his documents that he already in his hands. I identified the driver by his Florida driver's license as, Jose E Batres Batres told me that he was just stopped for speeding and did not know why I had stopped him for I explained to Batres the reason for stopping him Batres told me that he knew about the move over law and stated that he saw the mark police vehicle parked on the side of the road conducting the traffic stop. performing the exercises and that he is not currently taking any medication

Officer A Cabrera arrived on scene as the back-up officer As I was inside my vehicle, Batres exited his vehicle After repositioning my patrol vehicle, I had Batres stand in front of my vehicle I advised Batres that I was conducting a DUI investigation and asked him if he would submit to some roadside sobriety exercises to which he agreed Batres told me that he did not have any medical problems that would hinder him in

I conducted the HGN (Horizontal Gaze Nystagmus) test and observed all six clues Batres lacked smooth pursuit on both eyes, he had distinct and sustained Nystagmus at maximum deviation on both eyes and onset Nystagmus prior to 45 degrees on both eyes I had to tell Batres numerous times not to move his head while following my pen and to follow my pen with his eyes

Exercise # 1- Finger to nose did not keep his eyes closed and his head tilted back, failed to return his arms to his side as instructed, missed finger to nose every time (LRLRRL) I had to explain to Batres the instructions several times even after he stated that he understood the instructions and that he had no questions Batres raised his arms to the side and up not as instructed

Exercise # 2-One Leg Stand raised his left leg but stated that he was going to raise his right Swayed while balancing, was unable to keep his leg elevated, did not keep his leg straight and raised his foot less than 6 inches, did not count out loud as instructed and used his arms for balance

Exercise # 3- Walk and Turn could not maintain his balance during the instructional
