The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 04/04/2022, at approximately 1904 hours, Deputy R. Runcie (ABN 256135) and Deputy E. Espailat (ABN 255221), responded to 6122 North Dale Mabry Hwy, in reference to a vehicle crash. The defendant was operating a blue Mitsubishi Lancer (FL tag: GDUK42) and traveling north on N Dale Mabry Hwy. The front of Mitsubishi struck the rear of a red Honda Civic (FL tag: Z83ENP). The witness observed the defendant to be the driver at the time of the crash. The crash was investigated by Deputy Runcie, under HCSO case #22-261549 (DHSMV #24633769). The total estimated damage to the vehicles was \$1,000.00. Upon arrival, Deputy Runcie and Deputy Espailat observed the defendant to be sitting in the driver's seat of the Mitsubishi. Upon contact with the defendant, he had glassy eyes, his movements were slow/lethargic and his pupils were constricted. The defendant was asked to participate in the Standardized Field Sobriety Exercises (SFSE's), which he agreed. During the SFSE's, the defendant showed multiple signs of impairment and was placed under arrest for DUI with property damage. Implied consent was read (urine) and the defendant refused to provide a sample of his urine for chemical analysis. The defendant was positively identified via his Florida driver license. A query of the defendant revealed he has a prior refusal to submit to any sobriety test on 04/12/2014.
