The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the above listed date and time, I Trooper C. Winter was dispatched to a two vehicle crash located on Interstate 275 (State Road 93) northbound at mile marker 40B. I arrived on scene and noticed two vehicles on the outside shoulder facing north. Vehicle 01 (V01) was a white 2018 Chevy Silverado North Carolina license plate #JKL1130 and Vehicle 02 (V02) was a white 2020 Toyota Corolla Florida License Plate#QUBB81. V01 had front end damage and V02 with rear end damage. I asked both drivers what occurred and Driver 02 (D02) stated that he stopped in the outside lane and V01 failed to stop causing the front of V01 to collide with the rear of V02. I asked Driver 01 (D01) (who was later identified as Joseph V. Dweck NY DL# 871 077 280) what occurred and while speaking with me I noticed Mr. Dweck had the odor of an alcoholic beverage emitting from his breath, he displayed bloodshot watery eyes, mumbled his speech and was unsteady on his feet. At approximately 2015pm, I changed from a crash investigation to a criminal investigation for DUI (changing hats). I asked Mr. Dweck if he'd be willing to perform Field Sobriety Exercises (FSE's) in which he agreed.

-Horizontal Gaze Nystagmus (HGN) was explained and demonstrated using standardized instructions. Mr. Dweck lacked smooth pursuit in both eyes, had distinct and sustained nystagmus at maximum deviation in both eyes, and had nystagmus prior to 45 degrees. Mr. Dweck did not have vertical nystagmus.

-The beginning of the walk and turn evaluation was explained and demonstrated using standardized instructions. Mr. Dweck was asked to use the white line to walk across while doing the exercise. During the instructional phase, Mr. Dweck stepped off the line while in the starting position. On the first step Mr. Dweck stepped off the line, he would also raise his arms above six inches, and on the 5th step, stepped off the line.

-The beginning of the One Leg Stand evaluation was explained and demonstrated using standardized instructions. While demonstrating the exercise, Mr. Dweck put his foot down on "one thousand and three", he then proceeded to start the count over, and placed his foot down on, "one thousand and five" started the count over again and placed his foot down on "one thousand and two." At approximately 2025 pm I placed Mr. Dweck under arrest for DUI. Mr. Dweck was properly handcuffed, double locked and placed in the back seat of my patrol vehicle FHP1573. At approximately 2050pm, implied consent for

breath was read and Mr. Dweck denied to provide a sample, I arrived at Orient Jail at approximately 2108pm and Mr. Dweck was turned over to Hillsborough County Sheriffs Office for further booking procedures.
