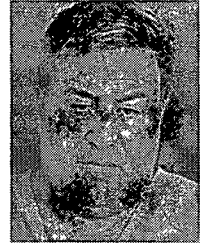

Probable Cause Affidavit

Before me this date personally appeared ALSHAIER, ELIAS J (3777) who being first duly sworn deposes and says that on 12 day of February (year) 2022 at 8300 W OAKLAND PARK BLVD, SUNRISE, FL 33351 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Sgt Rodriguez advised me that he witnessed the offending vehicle at the approximate 8300 block of W Oakland Park Blvd and travelling in the eastbound lanes As the vehicle continued east, Sergeant Rodriguez observed the driver, later identified by New Jersey identification card as the adult defendant Joseph MANZI, activate his right turn signal numerous times without changing lanes The vehicle would then begin to straddle two lanes as, appear as if it were going to complete a lane change, before veering back to the previous lane Sergeant Rodriguez said that the defendant did this numerous times The defendant then swerved from the far-right lane to the far-left lane with his right turn signal activated When Sergeant Rodriguez effected a traffic stop and contacted the defendant, he said that he was coming from Cheers, a local bar, and he could smell the odor of an alcoholic beverage emanating from the defendant's breath

I then contacted the defendant while he was still in actual, physical control of the vehicle I noticed that he had a flushed red face, glassy red eyes, was slurring his speech and had the odor of an unknown alcoholic beverage emanating from his breath at conversational distance The defendant stated that he was just coming from Solid Gold Strip club, which is located in Pompano Beach, FL The defendant now declined coming from Cheers and said he did not consume any alcohol He also said that he did not consume any chemical or controlled substance The defendant expressed that he is overweight, has high blood sugar and has diabetes He confirmed that he was not experiencing any medical related issues and did not need an ambulance The defendant told me that he was "not fucked up"

Based on my observations, I asked the defendant to participate in Standardized Field

Probable Cause Affidavit

Before me this date personally appeared ALSHAIER ELIAS J (3777) who being first duly sworn deposes and says that on 12 day of February, (year) 2022 at 8300 W OAKLAND PARK BLVD, SUNRISE, FL 33351 (crime location)

the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

Sobriety Exercises, to which he refused I proceeded to advised the defendant of his Taylor Warnings He continuously asked why he had been pulled over and would not consent to participate in the exercises Ultimately, the defendant refused to participate after ample time to comply He was immediately placed under arrest at 0128 hours

At BSO BAT, the defendant refused to provide a sample of his breath for the purpose of determining its alcohol content On BAT video, I read the defendant FIC, to which he again refused at 0220 hours It should be noted that while inside the BAT facility, the defendant made the following statements Fucking white trash, fucking black assholes, these fucking crybabies with dread shooting everybody up got me sitting here like a fucking criminal, suck my dick'

Based on the results of my investigation, I have probable cause to prove the defendant did unlawfully operate a motor vehicle, while under the influence of alcohol, in violation of FSS 316 193-1 It should be noted that the defendant did not present a valid driver's license during this investigation and only had an identification card on his person He was later delivered to BSO Main Jail for further processing
