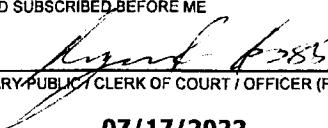
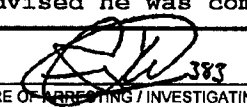

	On 07/16/2022 at approximately 2223 hours, I responded to the area of 1200 N Alternate A1A (S.R. 811 Intracoastal Waterway Bridge) in the Town of Jupiter, Palm Beach County, Florida at the request of Officer Schneider, who had conducted a traffic stop. At the time, I was driving an unmarked Jupiter Police Department patrol vehicle (vehicle 2109), I was wearing a JPD uniform clearly identifying myself as a Jupiter Police Officer, and I was wearing my department-issued Axon body camera.								
	Upon arrival, I made contact with Officer Schneider, who advised the following: He was conducting routine patrols when he observed a blue Ford pickup bearing FL tag # HFQS48 traveling southbound on S.R. 811 in the area of Riverside Dr. Officer Schneider advised the vehicle was extremely loud while driving and it sounded as though the vehicle was driving on a flat tire. When Officer Schneider saw the vehicle, he confirmed the vehicle was in fact driving on a completely flat front driver side tire. Officer Schneider attempted to conduct a traffic stop on the vehicle and activated his emergency lights at the southern base of the S.R. 811 bridge. The pickup continued to travel southbound for several hundred yards and Officer Schneider activated his siren several times while behind the vehicle to gain the driver's attention. The vehicle ultimately stopped (facing south) in the outside southbound lane. Officer Schneider identified the driver to be Joseph Gehring (w/m; 05/29/1963) and noted Gehring had just put a piece of gum into his mouth. He also noted Gehring had slurred speech, was fumbling with the requested documents during the traffic stop, bloodshot/glassy eyes, and requested a traffic unit respond to the stop. See supplement from Officer Schneider.								
	I observed Gehring was standing outside the passenger side of his vehicle when I arrived. Gehring was leaning on the side of his truck. I made contact with him and observed he had bloodshot/glassy eyes and his speech was slurred. Gehring was chewing a piece of gum and had the general odor of an unknown alcoholic beverage on his breath, mixed with the mint odor of the chewing gum. Gehring advised he was coming from the

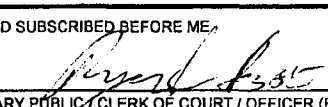

American Legion where he had a few drinks. I asked Gehring to estimate his level of impairment on a scale of 1 (being sober) to 10 (being sick) and he advised he was at a "2". Gehring advised he was willing to participate in Standardized Field Sobriety Tasks (SFSTs). Before completing the tasks, Gehring advised the only medical condition he had is high blood pressure for which he takes medication once daily (in the morning). Gehring advised he took his medication this morning. Gehring did not advise of any other medical/other issues. I first conducted the Horizontal Gaze Nystagmus task. I am a certified Drug Recognition Expert (IACP # 32395) and I conducted this task in accordance with my training. Gehring's pupils were of equal approximate size, he did not display resting nystagmus, and was able to equally track a horizontally-moving stimulus. I observed Lack of Smooth Pursuit in both Gehring's eyes. While checking for Distinct and Sustained Nystagmus at Maximum Deviation and the Onset of Nystagmus prior to 45 Degrees, Gehring would frequently either move his head, not focus on the stimulus, or snap his eyes back to mine. I did not observe Distinct and Sustained Nystagmus at Maximum Deviation or the Onset of Nystagmus Prior to 45 Degrees in either eye. Vertical Gaze Nystagmus was not present. Throughout the course of the HGN task, Gehring was swaying from side-to-side. I next conducted the Walk and Turn. It should be noted that a train was passing but I stood close to Gehring while giving the instructions, he advised he understood, and did not have any questions. Gehring started walking and lost his balance during the Instructions Stage. When told to begin, Gehring took one step appropriately then failed to touch heel-to-toe for the remainder of the 9 steps. Gehring took a total of 11 steps before turning. When he turned, Gehring threw his arms up from his sides as though he was frustrated or thought the task was unnecessary. I asked if he remembered what I told him to do after turning and he took 10 steps back down the line, missing heel-to-toe on each step and leaving a gap of approximately 8 to 10 inches between steps. Gehring intermittently raised his arms from his sides throughout the duration of the task. I then conducted the One Leg Stand. While providing Gehring the instructions, he routinely advised he is 60 years old and complained about the task. Gehring ultimately advised he understood the instructions and chose to raise his right leg off the ground, standing planted on his left. Gehring almost immediately lost his balance to the rear and stumbled behind him, to the left. Gehring attempted the task again but almost immediately placed his foot on the ground. Gehring tried a third time, mimicking his performance the first two times, placed his foot on the ground, threw his arms to his sides, and advised "that was three, right?". I reminded Gehring to continue the task until I told him to stop. Gehring then argued about the semantics of the instructions, saying I had only counted to three. When the 30 second period had elapsed, Gehring had attempted to raise his leg a total of 4 times, unable to keep it raised for more than a

P R O B A B L E C A U S E S T A T E M E N T	few seconds, and ultimately gave up - stating "I can't do that" and folding his arms across his chest while still complaining that he was 60 years old. Before conducting the Finger to Nose, Gehring demonstrated knowledge of his left and right hands. The cadence for this task was: Left, Right, Left, Right, Right, Left. When told to begin, Gehring failed to tilt his head back and close his eyes until I reminded him. On the first call of left, Gehring touched the pad of his left index finger just under the tip of his nose. On the first call of right, Gehring touched the tip of his right index finger to the outside of his right nostril. On the second calls of left and right, Gehring touched the pad of the appropriate finger. On the final call of right, Gehring touched the tip of his right index finger under the tip of his nose. On the final call of left, Gehring touched the pad of his left index finger to the tip of his nose. Gehring advised his highest level of education was 12th grade and that he was comfortable with the alphabet. Gehring completed this task appropriately but had to be reminded to close his eyes when told to begin. Based on the totality of the circumstances, I placed Gehring under arrest for DUI. Almost immediately, Gehring complained that he had completed the alphabet appropriately (a common complaint from impaired drivers when they performed well on the Rhomberg Alphabet task). I requested at roadside that Gehring provide a lawful sample of his breath for the purpose of determining the alcohol content. Gehring originally stated "I guess I have to." I explained to Gehring that it was his choice and read him Implied Consent so he had a complete understanding of what would happen should he choose to refuse the test. Gehring advised he did not understand Implied Consent and I explained it in layman's terms to him. Gehring still maintained that he did not understand Implied Consent and ultimately refused to provide a breath sample at 2250 hours. I find Probable Cause exists to charge Joseph Gehring with DUI pursuant to FSS 316.193(1)(a).

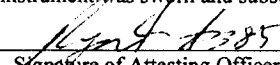
