The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 02/13/2022 at approximately 2313 hours, the defendant was observed operating a 2004 silver Nissan mini-van with Illinois tag CE33468 eastbound on Kennedy Blvd W approaching the intersection with Ashley Dr N at 55 MPH in a posted 35 MPH zone as confirmed by properly calibrated mounted RADAR unit and was observed failing to maintain a single lane. Contact was made with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, unsteady on his feet, and had the odor of an alcoholic beverage coming from his breath. The defendant confirmed drinking prior in the day and exhibited additional clues of impairment during SFSTs. The defendant submitted to a breath test which produced a BrAC of 0.208/0.203. The defendant was positively identified via DHSMV photograph.
