The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/16/2021, at approximately 0223hours, Deputy R. Weibley ABN 257012 conducted a traffic stop at Hillsborough Av W / Air Cargo Rd on a grey Honda bearing FL tag IYBV94 (VIN:5FN9F6H08GB108189) after being dispatched to a reckless driver call for service with the comments of the call advising a vehicle with no lights on was traveling eastbound on Hillsborough Av W from Memorial Hwy. Deputy Weibley located the vehicle, observed the defendant operating the vehicle, and detected signs of impairment. Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from his breath, his eyes were bloodshot and glassy, his speech was slurred, and he was unsteady on his feet. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant refused to do, and he was subsequently arrested. The defendant refused to provide a lawful breath sample to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1, to which he replied "It's obvious, I already told you." It should be noted the defendant stated multiple times he would not provide a lawful sample of his breath to determine his BrAC. The defendant was identified via FL DL. The defendant was given a DUI citation A71TQ2E which reflects the DUI charge.
