The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/06/2021, at approximately 0336 hours, the affiant conducted a traffic stop on a grey Toyota Corolla, bearing Florida tag 13ADFJ (VIN:5YFBURHE5JP842955), for headlights not in use. Upon contact with the defendant, the affiant detected the distinct odor of an alcoholic beverage emanating from his person, observed his eyes to be red/bloodshot and watery, and his balance to be unsteady. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which he refused to do. The defendant was then placed under arrest for DUI based on the totality of the circumstances. The defendant was transported to CBT, where he refused to provide lawful samples of his breath after Implied Consent was read and understood. A DAVID query of the defendant revealed he has a previous refusal to submit to a lawful breath test on 04/01/2011. The defendant was positively identified via his Florida driver's license.
