On 1/15/22 at approximately 11:15 pm, I observed a white Chevrolet pickup, bearing FL tag JYBB14, eastbound on the Gandy Bridge exceeding the speed limit and consistently drifted into the outside shoulder and back into its lane. I conducted a traffic stop on the truck on the east side of the bridge at the FWC boat ramp facility and contacted Mr. Joshua E. Whitney as the driver. During my conversation with Mr. Whitney during the stop, he was slurring his words, had blood-shot and watery eyes, and emitted the odor of an alcoholic beverage from his breath. I asked Mr. Whitney to exit the vehicle and he was unsteady on his feet to keep his balance. Due to my suspicions of impairment, I asked Mr. Whitney to perform Standardized Field Sobriety Exercises (SFSE), which he agreed to perform. Mr. Whitney performed poorly on the SFSE and was placed under arrest for Driving Under the Influence (DUI). Mr. Whitney was transported to the HSCO Orient Road jail Central Breath Testing and provided two breath samples of 0.248 g/210L and 0.231 g/210L. Mr. Whitney was booked without incident. The above listed events took place in Hillsborough County, FL.
