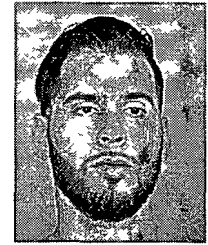

PROBABLE CAUSE

On September 16th, 2017 as I was conducting my duties as a State Trooper I backed up Trooper Jose Jimenez #1842 that was on a traffic stop on SR 842 (Broward Blvd) SW 11th Avenue. As I exited my vehicle I noticed that Trooper Jimenez had stopped a silver in color Toyota (FL TAG# 1339ZG) for the left headlight being out. I then walked up to the vehicle and introduced my self to the driver who I later identified by his FL DL as Jovanny Davila (FL DL# D140420933610). I then asked the driver if he knew why he was being stopped and Mr. Davila advised me that he did not know why he was being stopped. I then advised Mr. Davila that he was being stopped for his left headlight being out. As I was speaking to Mr. Davila I could smell an odor of an alcoholic beverage coming from the inside of the vehicle. I also noticed that Mr. Davila had blood shot watery eyes. I then asked Mr. Davila to exit the vehicle and follow me back to the front of my patrol vehicle FHP 0117. As I was speaking to Mr. Davila I could smell a strong odor of an alcoholic beverage coming from his facial area. I then asked Mr. Davila if he would like to do SFSE and he advised me that he would do the exercises. Prior to beginning the exercises I asked Mr. Davila if he was wearing any contacts and he advised me that he did not use contacts. I then asked him if he had any injuries that would prevent him from doing the exercises and he advised me that he did not have any injuries that would prevent him from doing the exercises.

At approximately 3 11 am I began the HGN test. I asked Mr. Davila to stand in front of me with his feet together and hands down by his side. I then advised Mr. Davila to follow the tip of my pen with his eyes only and to not move his head as he followed the pen with his eyes. I then asked Mr. Davila if he understood the instructions of the exercise and he advised me that he understood the instructions of the exercise. I also had to advise Mr. Davila 2 times to not move his head as he followed the tip of my pen with his eyes. Mr. Davila had equal pupil size in both eyes, he had lack of smooth pursuit, Nystagmus at maximum deviation, and on set prior to 45 degrees.

At approximately 3 13 am I began the Walk and Turn exercise. The exercise was done on a level and dry roadway. I asked Mr. Davila to place his left foot in front of him and to place his right foot in front of his left foot touching heel to toe. I also asked Mr. Davila to place his arms down by his side and to stay in that position until I was done giving him the instructions of the exercise. I asked Mr. Davila if he understood the instructions I gave him and he advised me that he did understand the instructions. On the first series of 9 steps Mr. Davila did not touch heel to toe on his 2nd to 3rd step or 3rd to 4th step. Mr. Davila raised his arms for balance more than 6 inches. On the second series of 9 steps Mr. Davila also failed to touch heel to toe on his 3rd to 4th step and on the 6th to 7th step. Mr. Davila also raised his arms for balance more than 6 inches.

At approximately 3 15 am I began the One Leg Stand. I asked Mr. Davila to stand in front of me with his feet together and arms by his side. I then explained the exercise to Mr. Davila and asked him if he understood the instructions and he advised me that he did understand the instructions. Mr. Davila raised his right foot. Mr. Davila dropped his right foot 2 times. Mr. Davila raised his arms more than 6 inches to keep balance. Mr. Davila was also swaying as he was doing the exercise. Mr. Davila skipped a number and counter from 1012 to 1014 skipping 1013.

At approximately 3 20 Mr. Davila was placed under arrest for DUI. I searched Mr. Davila and placed him in the rear seat of my patrol vehicle FHP 0117. Mr. Davila's belongings were given to the passenger in the vehicle. At approximately 3 27 am I asked Mr. Davila if he would like to provide me with a breath sample and he advised me that he did not want to provide me with a breath sample. At approximately 3 28 am I read Implied Consent to Mr. Davila and he advised me that he would provide me with a breath sample.

At approximately 3 37 am myself and Mr. Davila were en route to the BAT, starting mileage was 2316. At approximately 3 43 am we arrived at the BAT, ending mileage was 2318. While in the BAT the BAT Technician S. Tillman did the 20 minute observation. The first breath sample that Mr. Davila provided he blew a 158 at 4 11 am. On the second breath sample he blew a 164 at 4 14 am. At approximately 4 38 am myself and Mr. Davila were en route to the Broward County Jail for booking, beginning mileage was 2318. At approximately 4 44 am we arrived at the Broward County Jail, ending mileage was 2320. Shortly after Mr. Davila was turned over to the deputy at the Broward County Jail for booking.

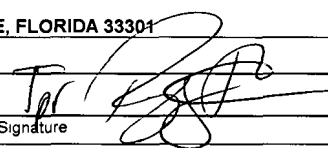

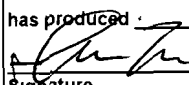
