The defendant was stopped for running a stop sign. The defendant also swerved as she made the turn while running the stop sign. The defendant then hit the curb as she was pulling over for the traffic stop. The defendant was driving her 2014 Toyota Prius, bearing FL tag #EZNL49. Upon making contact with the defendant, she displayed multiple signs of impairment, including: slurred speech, a strong odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, inappropriate laughing, and admission to consuming alcoholic beverages, and difficulty dividing her attention. The defendant exhibited several clues of impairment during the SFSEs, and was arrested for DUI. The defendant later refused to submit to the breath test, despite acknowledging the Implied Consent Warning.

The defendant identified herself via her FL driver's license.
