The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/22/2022 at approximately 0133 hours, TPD Ofc. R. St. Fleur conducted a traffic stop on a gray 2022 Tesla SUV with Florida tag 09BXBL at the intersection of 7th Av E and 24th St N after the vehicle was observed traveling with the tailgate open making the license plate unreadable. TPD Ofc. R. St. Fleur made contact with the driver/defendant, observed indicators of impairment, and requested a DUI investigation be conducted. I responded to the scene and made contact with the driver/defendant who was observed to have bloodshot/glassy eyes, slurred speech, appeared to have gotten lost on the way back to his residence, had a noticeable sway while standing, and had the odor of an alcoholic beverage coming from his breath. The defendant exhibited clues of impairment during SFSTs and was arrested for DUI. During the search incident to arrest, two paper wristbands were located on the defendant with one stating "Club Level". The wristbands are commonly utilized as admission into clubs/nightclubs. Also during the search incident to arrest, two receipts were located in his front left pocket for alcoholic beverages from "Prana" a local nightclub/bar. The defendant refused to submit to the requested breath testing after being read Implied Consent. The defendant was positively identified via DHSMV photograph.
