| <p>The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:</p> <p>The defendant caused a crash resulting in minor personal injury and \$40,000 in property damage when he rear-ended the victim's vehicle while both vehicles were in motion. The defendant was driving his 2021 Honda Pilot, bearing FL tag #DMND95, west in the westbound lanes of W. Courtney Campbell Cswy just east of the Hillsborough County Line. The defendant was positively identified by a witness as the driver at the time of the crash. Upon making contact with the defendant, he displayed multiple signs of impairment, including: slurred speech, a strong odor of an alcoholic beverage on his breath, bloodshot/glassy eyes, and post-Miranda admission to consuming alcoholic beverages and feeling "buzzed". The defendant exhibited several clues of impairment during the SFSEs and was arrested for DUI with property damage/injury.
