The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 05/15/2022 at approximately 2242 hours at the above-mentioned incident location, the defendant and victim were engaged in a verbal argument over the victim's use of the defendant's phone. The victim was located inside the bathroom of the residence when the defendant opened the bathroom door with a thin metal shower rod in her hand. The defendant utilized the shower rod to hit the juvenile victim on the left arm, lower back, and the top of her head area. These actions were intentional and against the juvenile victim's will. The juvenile victim suffered a raised red welt approximately the same diameter as the thin metal shower rod on her left arm and redness to her lower back area. The defendant is the juvenile victim's biological mother. The juvenile victim identified the defendant as the one who committed the offense. The defendant was identified via her FL DL.
