PROBABLE CAUSE

Before me this date personally appeared, (Officer Farah #867), who being first duly sworn deposes and says that on the (16) day of (Sept) (2017) at [REDACTED] the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

The above listed defendant (Karen Pemberty), was involved in an argument with her live in husband (suspect/victim [REDACTED]). During the course of the argument, Karen struck her husband on the left side of his face with what she described as a slap. Karen stated that this was in self-defense because he had pulled her hair because she did buy food for him and tore a family picture. Post Miranda, the defendant admitted to the slap but stated that it was in self-defense. There were no visible injuries to her husband's face and no independent witnesses to the fight. [REDACTED] was also arrested for pulling Karen's hair as the primary aggressor could be determined. Both parties refused to prosecute.
