The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 12/23/2021, the defendant was the front seat passenger in a black Ford F-150 (KY AKX143 VIN: 1FTDX18W4VKC33984) which was lawfully stopped for having a license plate that expired on 03/31/2021. Small baggies consistent with street level narcotics sales were observed in plain view on the front passenger floorboard and the defendant admitted to the baggies being used to contain marijuana, neither occupant was prescribed medical marijuana. A probable cause search of the vehicle was conducted and a loaded syringe was located in the glove box directly in front of the defendant. The syringe contents tested presumptive positive for methamphetamine. Also in the glove box, a baggie containing a white powdery substance was located and field tested presumptive positive for cocaine. Additional baggies were located with containing a crystal like residue that field tested presumptive positive for methamphetamine. Tucked under the middle seat, a plastic box was located which contained two white, triangle pills (P D 8) which were identified as Dilaudid 8 mg and a Schedule II controlled substance. All found narcotics were found closest to the defendant and within her immediate control. The defendant admitted to possession of the prescription pills, which she did not have a valid prescription for. The defendant was positively identified by her Florida driver license.
