The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a black 2019 Honda Civic (FL Tag #KZMG90) eastbound on Platt St W, when she stopped and made a U-turn. This section of Platt St W is a 1-way road with eastbound traffic only. After turning around, the defendant turned around again and stopped perpendicular in the roadway, blocking all eastbound traffic.

During the traffic stop for the 1-way and traffic blocking infractions, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, lethargic appearance, made slow/deliberate movements, she was disoriented, and had an odor of an alcoholic beverage stemming from her breath.

The defendant was arrested for DUI following a poor performance on SFSEs, and was taken to booking.

While at CBT, the defendant willingly took a breath test, providing 2 valid samples measuring .101/.103 BrAC.
