that he and the defendant, Karla Junieth Rodriguez Rioz (32 YOA), are related by marriage. The victim stated that the defendant caused multiple lacerations to his upper chest, upper back while using her hands during an argument over allegations of infidelity. Additionally, the victim stated that the defendant tore his shirt.

I observed multiple lacerations on the victim's upper chest, upper back, and left shoulder. I also observed the victim's shirt to be torn.

The defendant advised that she did cause the injuries to the victim during the argument.

The defendant was subsequently transported to the Coconut Creek Police Department for processing and then transferred to the Broward County Jail without incident (Unit 1415). The defendant was turned over to jail staff.

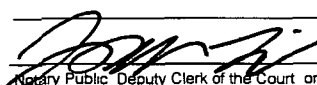
