The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a 2007 red Nissan Altima bearing a Florida license plate of 905PLL. She was traveling west on E Kay St and caused a traffic crash by failing to maintain her lane and subsequently struck the victim's vehicle. The defendant was positively identified as the driver at the time of the crash. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, and an admission to consuming alcohol. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. The defendant was identified by her FL DL.
