

The argument escalated when the victim refused to leave without her dog Mr said that the victim mother to calm him down, and the defendant slapped the phone out of her hand, inadvertently slapping her in the face with an open right palm intervened and tried to take the defendant down to the floor After a brief fist fight, Mr had the defendant on the floor in a headlock until he calmed down They then hugged and the fighting ended Shortly after, the defendant then went to his vehicle with the dog and Ms followed When she attempted to remove the dog from the car, Mr the defendant push her to the floor to keep her from taking the dog Mr intervened again, and the defendant pushed him into a nearby vehicle, causing damage to the passenger side mirror The defendant took his dog back into the apartment where he locked himself in the bedroom until BSO units were called to the scene by neighbors who heard the commotion The victim admitted to being under the influence of alcohol and could not recall the details of the incident She also stated she did not want to press charges against the defendant and said she only got pushed out of the way while the defendant and Mr fought She stated she was never punched or struck by the defendant She \* \* \* Continued \* \* \* I swear the ab pent is correct and true to the best of my knowledge and belief GIBSON, GERONIMO J (20125) Dania Beach Officer's Name/CCN Officer's Division December GIBSON, GERONIMO J (name and title) who is personally known to me or has produced
