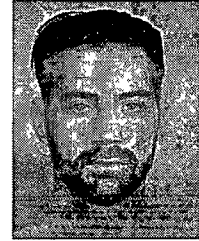

approximately 5 5 years and have lived together since

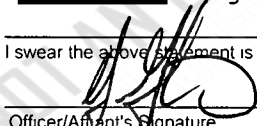
Mr. _____ said that after a night of drinking, around 4 00 a m , the group of friends went back to the above listed apartment and the defendant and victim started arguing The defendant became increasingly aggressive and screamed for everyone to leave the apartment, including the victim's Emotional Support dog The argument escalated when the victim refused to leave without her dog Mr. _____ said that the victim tried calling Mr. _____ mother to calm him down, and the defendant slapped the phone out of her hand, inadvertently slapping her in the face with an open right palm Mr. _____ intervened and tried to take the defendant down to the floor After a brief fist fight, Mr. _____ had the defendant on the floor in a headlock until he calmed down They then hugged and the fighting ended

Shortly after, the defendant then went to his vehicle with the dog and Ms. _____ followed When she attempted to remove the dog from the car, Mr. _____ saw the defendant push her to the floor to keep her from taking the dog Mr. _____ intervened again, and the defendant pushed him into a nearby vehicle, causing damage to the passenger side mirror The defendant took his dog back into the apartment where he locked himself in the bedroom until BSO units were called to the scene by neighbors who heard the commotion

The victim admitted to being under the influence of alcohol and could not recall the details of the incident She also stated she did not want to press charges against the defendant and said she only got pushed out of the way while the defendant and Mr. _____ fought She stated she was never punched or struck by the defendant She

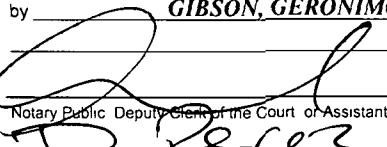

stated the defendant did slap the phone out of her hand, however, she said he did not hit her face

The other individuals present at the time of our arrival said they were not inside the apartment when the incident happened and did not see any physical confrontation The defendant confirmed he was in a fight with Mr [REDACTED], but he did not touch or strike Ms [REDACTED] He did confirm he slapped the phone out of Ms [REDACTED] hand but he did not hit her face

Due to the statement provided by Mr [REDACTED] the defendant was arrested and transported to the Broward Main Jail
