Before me this date personally appeared DULCIO PIERRE G (3630) who being first duly sworn deposes and says that on 6 day of February, (year) 2022 at [REDACTED] (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

RETURNED TO THE APARTMENT INTOXICATED AND ASSAULTED HIM HE ADVISED BOTH PARTIES WERE INVOLVED IN A VERBAL DISPUTE ABOUT A SITUATION THAT OCCURRED A FEW DAYS AGO

THE VICTIM STATED THE ARRESTEE WALKED UP TO HIM WHILE HE WAS ON THE COUCH AND BEGAN AND BEGAN PUNCHING HIM MULTIPLE TIMES TO HIS FACE THE VICTIM STATED WHILE THE VICTIM WAS PUNCHING HIM, SHE PROCEEDED TO KICK HIM WHILE HE WAS ON THE COUCH AS WELL.

OFFICERS OBSERVED A LACERATION ON THE VICTIMS` RIGHT CHEEK, WHICH WAS BLEEDING AND SWOLLEN.
