The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a white Hyundai SUV bearing a Florida license plate of Z104YD. She was illegally parked on a sidewalk in front of 210 S 12th St. A concerned citizen called the police advising the female subject in this vehicle was honking the horn and intoxicated. Upon making contact with the defendant, the vehicle engine was on and the defendant was in the driver's seat. She displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, very slurred speech, a strong odor of an alcoholic beverage, unsteady stance, unsteady walk, and an admission to consuming alcohol. In addition, when the defendant opened the vehicle door there was an open 375ml bottle of vodka in the door pocket. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the implied consent warning. The defendant was identified by her FL DL.
