A search of Cantu's purse which contained her Florida Driver's license along with her admitting to the purse being hers revealed a small glass containing which contained off white chalk like substances which field tested positive for cocaine utilizing a Cobalt Thiocyanate test kit. The field tested positive cocaine had a weight of .3 grams Per Florida State Statute 893.13(6a) I find probable cause to arrest Cantu for possession of cocaine.
