The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above date and time Deputy A. Hernandez (256469) conducted a traffic stop on the defendant who was operating his vehicle described as a 2018 white Jeep Cherokee bearing NH tag (1P401) for having an inoperable front headlight. Upon Deputy Hernandez making contact with the defendant and sole occupant of the vehicle and he detected several indicators of impairment. The affiant arrived on scene and made contact with the defendant and also noted indicators of impairment. The defendant was asked to participate in SFSEs which she agreed to do, After completing the first exercise the defendant refused to continue with the remaining exercises. Due to the indicators observed by myself, Deputy Hernandez, and the totality of the circumstances, the defendant was placed under arrest for DUI. The defendant was transported to Brandon Regional Hospital to be evaluated for chest pains. While inside ER room # 6 the defendant was asked to provide a lawful blood sample which she refused to provide. The defendant was then provided her implied consent warning. Post implied consent the defendant still refused to provide a lawful blood sample. The defendant was later released from the hospital and transported to ORJ without further incident. The affiant verified the defendant's identity via NH DL.
