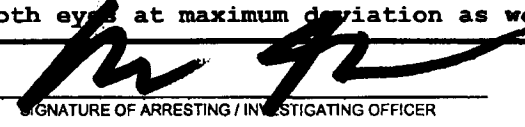

On 07/17/2022 at approximately 2338 hours, this Officer was stopped at a red light in the inside left-hand turn lane of east bound PGA Blvd at the intersection of Prosperity Farms Rd, PBG, FL. Body worn camera and in car video were used during the investigation.				
The vehicle directly in front of this Officer was a white Hyundai hatch-back (PCRM39/FL), which this Officer conducted an FCIC/NCIC records check and observed an abnormality. The records check yielded the registered owner, Kathy Perez (OF) had a suspended driver license since 06/29/2022 reference failure to pay a financial responsibility. This Officer and the Hyundai conducted lawful U-turns and traveled west bound on PGA Blvd where the vehicle was stopped just east of Kew Gardens Av, PBG, FL. The vehicle was stopped in accordance with Kansas v. Glover. Prior to making contact, this Officer observed a photo of Perez to ensure the proper person was stopped. Upon contact with the driver, this Officer was able to confirm same.				
Perez acknowledged the suspension and mentioned not having enough money to pay for it. This Officer observed Perez to have glassy watery eyes, flushed face, slurred speech and the obvious odor of an unknown alcoholic beverage emanating from her breath at conversational distance. Perez said she coming from work at La Masseria, which is west of the location. Perez said La Masseria closed at 2330 hours, this was later determined to be incorrect, as the location closed at 2200 hours. Perez later said she was on her way home, which was determined to be near the location of the stop and opposite the location where she was originally observed. Perez admitted consuming to consuming one and a half drinks on this night.				
The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used was a Stylus Streamlight with an illuminated red tip. Perez had a lack of smooth pursuit in both eyes and sustained involuntary jerking in both eyes at maximum deviation as well as

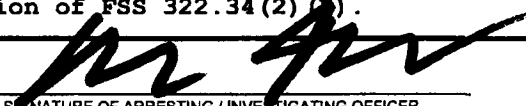

the onset of Nystagmus in both eyes prior to 45 degrees. Perez also had vertical gaze Nystagmus in both eyes, twice. The second exercise conducted, was the Walk and Turn. The line used was a strip of yellow tape placed upon the pavement by this Officer. During the instructions, Perez exited the starting position at least nine times and started one time, after being told not to start until told. During the instructions Perez also uttered "I just got a DUI". This Officer attempted to advise Perez of her Taylor Warnings, to which she did not allow this Officer to explain and said she understood. During the first set of steps, Perez raised her arms more than six inches from her sides and took 14 steps rather than nine. Perez conducted an improper turnaround by way of removing her lead foot from the line and walking around, while also raising her arms from her sides. During the return set of steps, Perez stepped her rear foot off the line during her second step. Perez stepped next to the line on her ninth step and took 16 steps rather than nine. The third exercise conducted, was the One-Leg Stand. During the exercise, Perez raised her right foot. Perez initially was not looking at her raised foot nor counting aloud. When this Officer told her to look down at her raised foot, she immediately dropped it to the ground and said "no I can't look". Perez then lost her balance and stepped out of the exercise position and took 32 seconds to again raise her right foot. Once she raised her foot again, she was looking up and began swaying and raised her arms more than six inches from her sides. Perez then placed her foot down two more times, thus ending the exercise for placing her foot down a total of three times. Based on this Officer's observations, Perez was placed under arrest at 2351 hours. On the roadside, this Officer requested Perez provide a breath sample for the purpose of determining its alcohol content, to which she refused. This Officer read Florida Implied Consent to Perez via Florida DOT Cards, to which she acknowledged then began to argue with this Officer, ultimately refusing at 2358 hours. While transporting Perez to PBGPD Booking, Perez began to beg and cajole this Officer to let her go, saying things such as "I'll do anything" and "I can give you money", although not making a specific offer. It should be noted, Perez has a prior refusal to submit to a lawful sobriety test on 12/02/2020 in Palm Beach County, FL. Perez also had one prior license suspension conviction dated: 12/14/2020 in Palm Beach County, FL. Based on the results of the investigation, this Officer has probable cause to prove Kathy Perez operated a motor vehicle, in the state of Florida, while under the influence to the extent her normal faculties were impaired, in violation of FSS 316.193(1)(A). Perez refused to submit to a lawful sobriety test, with a prior refusal, in violation of FSS 316.1939(1). Lastly, Perez knowingly operated a motor vehicle with a suspended driver license with a prior conviction, in violation of FSS 322.34(2)(a).

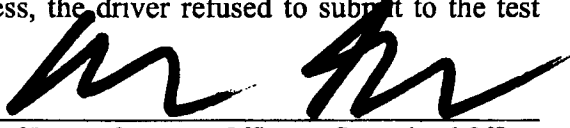
