The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 03/31/2022, at approximately 2334 hours, Corporal B. Dobson (ABN 4809) was on proactive patrol and traveling northbound on South US Hwy 301. Corporal Dobson observed a white GMC Acadia (FL tag: WVBX36) drive through construction cones (blockade) and enter into a construction zone. The GMC then sideswiped a silver construction Chevrolet Silverado (FL : NFUS83). The vehicles and property sustained approximately \$1,000.00 The traffic crash was investigated by Deputy M. Rock (ABN 260925) under HCSO case #22-251422 (DHSMV #24631093). Upon contact with the defendant, she had glassy eyes and the distinct odor of an alcoholic beverage emitted from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises (SFSE's), which she agreed. During the SFSE's, the defendant showed signs of impairment and was placed under arrest for DUI with property damage. Implied consent was read and the defendant refused to provide a lawful sample of her breath. The defendant was identified via her Florida driver license.
