The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did . On 11/24/2021, at approximately 2240 hours, at 10318 Goldenbrook Way, FL 33647, the defendant and victim were involved in a verbal argument. This argument turned physical when the defendant unlawfully grabbed the victim by his shirt and scratched the victim on the neck with her fingernails. The victim had multiple superficial scratch marks and redness on both sides of his neck. The victim and the defendant have lived together for approximately three years as a family and have been in a romantic relationship for approximately two and a half years. The victim positively identified the defendant as the one who willfully and intentionally committed the offense against his will. The defendant's identity was confirmed via her Connecticut DL and RMS query.
