On the <u>28</u> day of <u>July</u>, <u>2022</u> at <u>00:06</u> (Specifically include facts constituting cause for arrest.) On 7/27/2022 at approximately 2357hrs, I was dispatched as a backup officer to a disturbance call located in the area of 1209 Main St, Jupiter, Palm Beach County, Florida. Upon arrival I observed Jupiter Police Officers with a male detained in handcuffs and a female yelling and screaming and trying to push past people to get towards the male. The female was instructed multiple times to step away and she continued to disobey lawful commands while continuing to take officers attention away from their initial investigation. The female was later identified as WF Kaylee N. Magruder (1/30/2000) and she was continually disturbing the peace of residents in the area. Multiple neighbors in the area were outside due to Magruder screaming and refusing to depart the area. Attempts to speak with Magruder at a conversation level were made but Magruder continued yelling and screaming. Once it was determined that Magruder was no longer needed on scene she was again given multiple lawful orders to leave the area and she continued to refuse. Magruder's brother also attempted to get Magruder to leave the area and had to continually get in between Magruder and her boyfriend who was being arrested. Magruder was advised if she again refused to leave she would be arrested. Magruder refused to obey the lawful order and was screaming at officers to arrest her. Based upon my investigation, Magruder was arrested for Disorderly Intoxication for being intoxicated in a public place causing a disturbance and refusing to leave the area. Magruder was placed into handcuffs which were double locked and she was secured in the back seat of my patrol vehicle. Magruder was later transported to the Jupiter Police Department for processing and later turned over to the Palm Beach County Jail without incident.
