 On 03/16/2022 at approximately 1951 hours, TPD Ofc. M. Ryan observed a black 2020 Chevrolet SUV with New York tag JSF7000 pulling into the gas station located at 810 E Sligh Ave after a call for service was received reference the vehicle driving recklessly. Ofc. M. Ryan made contact with the driver/defendant who was observed stumbling out of the drivers seat of the vehicle, observed indicators of impairment, and requested a DUI investigation be conducted.

I responded to the scene and made contact with the defendant who was observed to have bloodshot/glassy eyes, dilated pupils, slurred speech, had the odor of an alcoholic beverage coming from her breath, and advised she had been drinking earlier in the day. Additional clues of impairment was observed during SFSTs and she was arrested for DUI. She refused to submit to the requested breath testing after being read Implied Consent.

The defendant was positively identified via New York drivers license.
