The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a gray 2016 Honda Civic, 4 door, Florida tag KAHJ32. The defendant drove in a manner in which the vehicle drifted in the travel lane so that the left and right side tires crossed onto and over painted lane markers numerous times. The defendant drove to the end of a merge lane and failed to merge in time, crossing partially into a painted safety zone. The defendant followed another vehicle too closely. The defendant accelerated to a high rate of speed, which was visually estimated and patrol car paced (TPD DUI unit 5055) at its highest speed of 106 MPH in a properly posted 55 MPH speed limit. A traffic stop was conducted. The defendant had difficulty searching for and locating her driver license, and displayed fumbling/clumsy fingers in the process. The defendant seemed confused and aloof. The defendant had a distinct odor of an alcoholic beverage coming from her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's speech was initially slurred, and remained mildly slurred. The defendant's face was flushed. The defendant denied consuming alcoholic beverages tonight. The defendant was asked to exit the vehicle, but she stalled and delayed as she tried to locate her vehicle keys. The defendant was unsteady exiting the vehicle, she swayed while standing, and her gait was mildly unsteady. The defendant initially refused to submit to Field Sobriety Exercises but agreed after being advised of the purposes of the FSE's and the potential outcomes if she refused. During the Walk and Turn Exercise the defendant stopped and refused to continue. The defendant was intentionally being difficult and passive aggressive. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances she was arrested for DUI. The defendant refused to submit to a lawful test of her breath for the purpose of determining its alcohol content after being advised of the Implied Consent Warnings. The defendant was positively identified by her Florida DL.
