The victim explained to the Officers that she did not currently or ever live with Heath por do they have any children in common. On 1/3/2022, The victim was brought to the police station by her mother to provide detectives with a sworn statement. The victim's mother had to drive her due to the extreme swelling of her eye, it was still not safe for her to drive. In summary, The victim explained that they returned home from New Year's Eve celebrations at approximately 0500 hours to Heath's residence (908 SW 18th ST). She indicated that immediately she knew that something changed, and Heath was angry. She stated that when they got into the residence, he began to argue with her and yell that she "triggered him". She stated that eventually the argument became physical, and Heath began punching her in the face with a closed fist. She stated that most of the blows were on the right side of her body. She stated eventually she fell to the ground. She indicated that the attack continued with punches and kicks. In an attempt to lessen the blows, she held up her hands and tried to protect her face. She explained that Heath kept punching and kicking her. The victim indicated that when he stopped, he immediately exclaimed that she could not leave the residence looking like "that" (due to her injuries). She stated that he asked where her cellular phone was and she pointed across the room. The victim explained that Heath walked over to her cellular phone and smashed it several times, completely destroying her phone. have her call police because it would "ruin him" and he would lose custody of his young daughter.

The victim indicated that the argument continued after he destroyed her cell phone. She stated that he then kept yelling at her and demanding "right answers" or he would hit her in the face again with a closed fist

The victim explained that Heath stated that he was going to have to keep her in the residence for several days so that her injuries would heal and no one would see them.

The victim indicated that Heath went around the residence and made sure all of the doors were locked so that she could not easily escape.

The victim stated that eventually they fell asleep and she woke up at approximately 1000 hours and Heath was still sleeping. She stated that she got up out of the bed, checked to see if he woke up, flushed the toilet, checked again to see if he woke up, got water, checked to see if he woke up, and walked around the residence to test if he would wake up. She stated that he remained sleeping the entire time and did not more. She explained that she was terrified that if he woke up he would continue to attack her.

The victim explained that when she realized he was going to stay asleep, she grabbed some of her property, her purse with her car keys and ran out of the residence in a t-shirt and her underwear, no shees or pants.

The victim described that she was terrified of attempting to leave the residence during

the altercation for fear of being injured more, or worse. She also indicated that he told her she could not leave for several days, all the doors in the residence where locked, he destroyed her cellular phone and never left her alone.

The victim stated that this is the fourth phone that Heath has destroyed since they started dating in May 2021. The victim indicated that there was also prior violence that she never reported but documented via photographs on her cellphone. The victim explained that she was willing to prosecute and was going to obtain a restraining order.

During the interview detectives observed the victims face to be severely swollen, bruising on both eyes, her eyes were partially swollen shut, left eye was blood shot, bruising on both ears, her right hand bruised and swollen, her right shoulder had a large bruise covering her entire bicep, bruising on her back and legs. The victim provided detectives with medical documents from Broward General Hospital that stated she sustained bilateral nasal bone fractures with a slight displacement bilaterally, fracture of the floor of the left orbit, soft tissue swelling, soft tissue air over the left side of the face and eye, soft tissue swelling over the right side of the face as
