The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 11/20/2021 at approximately 1421, your affiant was dispatched to the area of Dale Mabry Hw N and Bearss Av W in reference to a person acting strange. The person got into a gray in color Ford Bronco (FL#621WX) and began driving North bound on Dale Mabry HW N. Your affiant located the gray in color Ford Bronco, and observed it sitting at a steady green light for approximately 40 seconds before slowly moving forward in the far left lane. Your affiant observed multiple vehicles going around the slow moving vehicle, and got behind it at Dale Mabry Hw N, and Zambito Rd. Your affiant observed the driver of the vehicle slumped to the right side of the driver's seat, and their head down. I activated my emergency equipment in an attempt to conduct a traffic stop to check the welfare of the driver. The vehicle sped up, and stopped in the inside left turn lane at Dale Mabry Hw N, and Northdale Bl. I exited my vehicle and spoke to the defendant. I observed multiple signs of impairment which included slurred speech, droopy glassy eyes, and the odor of an alcoholic beverage which grew stronger as the defendant spoke. I requested the defendant turn off their vehicle and exit to complete field sobriety exercises (SFSE's), and the defendant complied. Once SFSE's began the defendant stopped and stated they did not want to complete the exercises, stating they were "gay." Based upon my observations, the defendant was arrested for DUI and transported to Central Breath Testing (CBT) where the defendant agreed to provide a lawful sample of her breath. The breath samples were provided to CBT Operator Snyder #4113 via the intoxilyzer 8000 (80-003387) showing sample 1 as 0.273 BrAC, and sample 2 as 0.290 BrAC. I completed a DUI Uniform Traffic Citation (A4047TE) for the infraction. The defendant was positively identified via their Florida issued driver's license #G626501825570.
