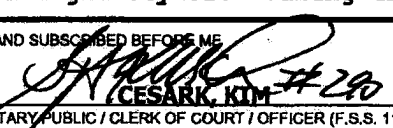
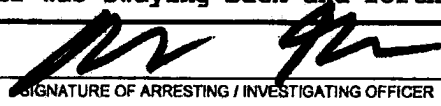

On the 10 day of June, 2022 at 21:36 (Specifically include facts constituting cause for arrest.) On 06/10/2022 at approximately 2136 hours, this Officer arrived in the parking lot of 4445 PGA Blvd, PBG, FL, to assist Ofc Hennessy 409 with a traffic stop. Body worn camera and in car video were used. Ofc Hennessy said he observed the vehicle, a BMW sedan (STE35/FL) traveling west bound in the east bound lanes of PGA Blvd near Interstate 95, PBG, FL. Ofc Hennessy further stated the vehicle then crossed back over into the west bound lanes, west of the interstate. After the vehicle crossed into the proper direction lanes, it had difficulty maintaining a single lane. Ofc Hennessy conducted a traffic stop on same at the location. This Officer made contact with the driver, identified via Florida Identification Card photo, Kevin Shaver (OF) while he was still seated in the driver seat of same. Shaver had low heavy eyelids, red watery eyes, slow slurred mumbled speech and delayed responses to questions. This Officer was able to detect the overpowering odor of an unknown alcoholic beverage emanating from his breath at conversational distance. Shaver said he was coming from "Palm Beach Circle" and was on his way to "pick up a girl". Shaver claimed to have consumed "not a drop" of alcohol on this night. Shaver further denied consuming controlled substance and/or Cannabis on this night. Based on this Officer's observations, Shaver was asked to exit the vehicle to participate in Standardized Field Sobriety Exercises, to which he complied. When Shaver exited the vehicle, he appeared uneasy on his feet and walked with an unsteady gait. Shaver said he did not have any medical conditions which would affect the exercises performed. The first exercise conducted, was the Horizontal Gaze Nystagmus. The stimulus used, was a Streamlight Stylus. During the exercise, Shaver was swaying back and forth,

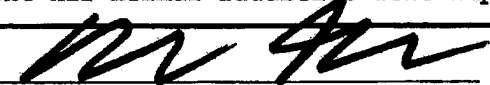

	eventually leaning back against the rear of his vehicle. Shaver also would not follow instructions. Shaver exited the exercise position multiple times and each time the stimulus passed from left to right across his face, he would stop and stare at this Officer's face. Shaver would also move his head in the direction of the stimulus, this Officer instructed Shaver multiples not to do this, however, he proceeded to continue. The only indicators this Officer was able to observe, were a lack of smooth pursuit in both eyes. This Officer determined Shaver was either too impaired or unwilling to follow instructions, thus the exercise was ended. The second exercise conducted, was the Walk and Turn. The line used was a line in the concrete, which was straight, level and clear of debris. During the instructions, Shaver had difficulty getting into and remaining in the starting position. Shaver repeatedly lost balance and stepped out the starting position. Shaver also started the exercise prior to being told to do so. Shaver then bent down and said he needed to tie his right shoe, which this Officer noticed was still tied. During the first set of steps, Shaver missed heel-to-toe on each step. Shaver kept his arms raised more than six inches from his sides and missed the line twice. During the turnaround, Shaver pivoted in both feet then stepped to the left off the line. During the return set of steps, Shaver missed heel-to-toe each step, kept his arms raised more than six inches from his sides and missed the line once. Shaver took eight steps rather than nine. The third exercise conducted, was the One-Leg Stand. During the instructions, Shaver was looking elsewhere while this Officer was explaining the exercise and not remaining in the position. Shaver also attempted to walk away from where he was told to stand. During the exercise, Shaver raised his right foot, citing an injury to that leg. Shaver then delayed raising his foot. Once Shaver raised his foot, he lost his balance, leaned to the left, raised his arms from his sides and placed his foot down. Shaver then claimed an injury, despite earlier stating he would be able to balance on one foot. Due to Shaver's aggressive body language, such as grimacing facial expressions, balled-up fists and attempting to walk away, this Officer placed Shaver under arrest at 2147 hours. On the road-side, this Officer requested Shaver to provide a breath sample for the purpose of determining its alcohol content, to which he refused. This Officer read updated Florida Implied Consent to Shaver, via Florida DOT cards, to which he acknowledged and again refused at 2156 hours. It should be noted, Shaver has a prior sobriety test refusal on 06/28/2013, in this county. Shaver also has a prior DUI conviction dated 12/08/2010 in Leon County, FL. As of this date, Shaver does not have a driver license issued to him. Based on the results of the investigation and the totality of the circumstances, this Officer has probable cause to prove Kevin Shaver operated a motor vehicle, in the state of Florida, while under the influence to the extent his normal faculties were impaired,

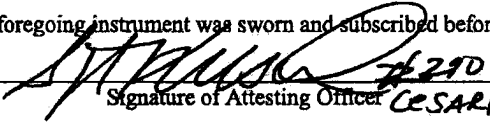
