The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a white 2020 Toyota Camry rental car (MI Tag #ELL3791) westbound on Dr. MLK Blvd Jr Blvd from Himes Av N, with no taillights illuminated. During the traffic stop for the taillight infraction, the defendant was slow to react and did not stop until Dale Mabry Hwy N. He was identified via a CT DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, tired/lethargic appearance, slow/deliberate movements, poor balance, he admitted to drinking "several beers 5 hours ago", and emitted a distinct odor of an alcoholic beverage from his breath. The defendant was arrested for DUI following a poor performance on SFSEs and was transported to booking. While at CBT, the defendant was read Implied Consent and willing provided 2 valid breath samples, measuring .177/.158 BrAC
