The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 06/03/2022, near the Velocity Automotive Service which is located at 314 E Brandon Blvd, Brandon, Florida 33511 the witness observed the defendant striking a retention wall and exiting a grey 2018 Mazda3 bearing Florida tag QUKY18 with an assigned VIN of 3MZBN1V37JM212392. Upon deputies contact with the defendant they observed multiple indicators of impairment. Deputy D. Bellamy ABN: 260625 responded to the scene and completed the traffic crash (22- 430979 // 24630290) Upon the affiant's contact with the defendant, I observed multiple indicators of impairment. While in direct contact with the defendant, I observed her to have bloodshot watery/glassy eyes, slurred speech, she was unsteady on her feet, she was disorientated, unable to hold a full conversation, and I smelled the odor of an acholic beverage emitting from her breath. The defendant agreed to participate in the field sobriety exercises while completing the exercise, she demonstrated further indicators of impairment. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she provided two lawful breath samples of .206 and .206. Further research via DAVID revealed the defendant was convicted guilty of DUI on 02/11/2020. As a direct result of the traffic crash the defendant caused approximately \$8,500 of damage. I further identified the defendant via her DAVID photograph.
