The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was operating a white 2015 Mercedes C250, 2 door, Florida tag EWFV46. The defendant drove in a manner in which she stopped short of the painted white stop line at a red light, drifted in the travel lane so that the vehicle tires crossed onto and over painted lane markers several times, drove through a painted safety/merge median, and had difficulty maintaining a consistent speed as the vehicle speeds fluctuated up and down unnecessarily. A traffic stop was conducted to check on the welfare of the driver to determine if she were sick, tired, distracted, or impaired. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot and watery, and her face was flushed. The defendant initially stated that she drank one alcoholic beverage tonight, and later stated she had "more than one". The defendant was unsteady exiting the vehicle, her gait was mildly unsteady, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances she was arrested for DUI. The defendant provided breath samples of .106% BrAC and .100% BrAC. The defendant was positively identified by her Florida DL.
