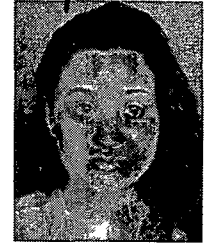

Before me this date personally appeared DALECKY TIMOTHY B (3633) who being first duly sworn deposes and says that on 8 day of February, (year) 2022 at 500 N BROADWALK HOLLYWOOD FL 33019 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

ON THE ABOVE DATE, TIME, AND LOCATION, I RESPONDED TO 500 N BROADWALK IN REFERENCE TO A PHYSICAL DOMESTIC DISTURBANCE THE CALL STATED THAT A WHITE FEMALE WEARING BLACK WITH A BABY STROLLER WAS STRIKING A HISPANIC MALE IN THE FACE UPON ARRIVAL, I OBSERVED A WHITE FEMALE MATCHING THAT DESCRIPTION AND A HISPANIC MALE WALKING WEST FROM THE ABOVE LOCATION TOWARDS ME

WHEN I MADE CONTACT WITH THE WHITE FEMALE, LATER IDENTIFIED AS ROBILLARD, SHE STATED THAT SHE GOT INTO AN ARGUMENT WITH HER HUSBAND OF OF 4 YEARS, [REDACTED], ABOUT HIM BEING INTERESTED IN ANOTHER GIRL AT THE BAR ROBILLARD STATED THAT NOTHING PHYSICAL OCCURRED

I SPOKE TO [REDACTED] WHO STATED THAT THEY GOT INTO AN ARGUMENT ABOUT ROBILLARD KISSING ANOTHER GIRL IN THE BAR [REDACTED] STATED THAT NOTHING PHYSICAL OCCURRED
