The defendant was driving a 2018 white Lexus SUV bearing an Alabama license plate of 2AA6541. She was traveling west on W Bay to Bay Blvd near S Emerson St and caused a traffic crash when she left the road and struck a large brick neighborhood association sign causing property damage of about \$5000. The defendant was identified as the driver at the time of the crash by the witness. Upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, a strong odor of an alcoholic beverage, and an unsteady stance. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning.

The defendant was identified by her FL DL.
