The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 03-18-2022, at 0119 hours, Deputy Dawson #259134 conducted a traffic stop at W Lumsden Road / Versant Drive on a gray Jeep Cherokee bearing FI tag DXBZ13 (VIN 1C4PJLDB8LD552223) to check on the welfare of the driver, due to the vehicle not maintaining a single lane. Deputy Dawson made contact with the driver (defendant) and observed her displaying indicators of impairment.
