 On 03/06/2022 at 2312 hours, I, Trooper Snyder, Adrienne M. 4958/1754, responded to a motor vehicle collision involving a black Honda Accord vs a Semi truck. On arrival I made contact with Driver 1, identified by Florida Drivers License as Ms. Ladianela Pons DOB: 01/06/1987, who stated she had no idea what happened then proceeded to tell me about her unpaid auto insurance. While Ms. Pons spoke, I observed her slightly swaying back and forth and an odor of alcoholic beverage was apparent. I observed Ms. Pons eyes to be bloodshot, glassy, and watery. I asked Ms. Pons if I could check her eyes for Horizontal Gaze Nystagmus (HGN) and she gave consent. Ms. Pons was instructed not to move her head, only her eyes during this exercise. Ms. Pons displayed a lack of smooth pursuit in the left eye and right eye, a distinct and sustained nystagmus at maximum deviation in her left eye and right eye, and an onset of nystagmus prior to 45 degrees in her left eye and right eye. No vertical nystagmus was detected. Ms. Pons was read her Miranda Rights at 0014 hours, declined Standardized Field Sobriety Exercises (SFSE's), and Invoked. Ms. Pons was read Implied Consent at 0043 hours and declined to submit breath/urine/blood. After Ms. Pons was advised the consequences of refusing to submit a lawful test, she continued to refuse. Ms. Pons has a previous refusal to submit on file, one prior DUI conviction, and two previous DWLSR convictions. Ms. Pons is currently suspended as of 02/07/2022. Ms. Pons was then transported to the Hillsborough County Jail on Orient Rd for booking and processing without incident. Nothing further.
