The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a white 2015 Fiat, 2 door, Florida tag HDAL60. The defendant drove in a manner in which the vehicle drifted onto and over painted lane markers numerous times, and followed another vehicle too closely as she flashed her high beam head lights at the vehicle. The defendant drove at speeds of 78-81 MPH in a properly posted 55 MPH speed limit, which was visually estimated and patrol car paced (TPD DUI unit 5055). A traffic stop was conducted for the purposes of checking on the defendant's welfare to determine if she were sick, tired, or impaired, as well as for unlawful speed. The defendant was slow to react to the indication given to stop. The defendant stopped inappropriately by stopping in the roadway rather than other locations off the main roadway. The defendant had a dazed, impaired look about her face. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, her speech was slurred, and she had cognitive issues as related to remembering what documents had been requested. The defendant stated she did consume three shots of vodka recently. The defendant was unsteady exiting the vehicle. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and she had difficulty following simple instructions. Based on a totality of the circumstances, the defendant was arrested for DUI. The defendant provided breath samples of .208% BrAC and .219% BrAC. The defendant was positively identified by her Florida DL.
