The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/12/2021, at North US Highway 301 and Jefferson Road, Thonotosassa, Florida 33592 Corporal D. Simpkins ABN: 230514 observed the defendant in physical control of a silver 2003 Toyota Corolla bearing Florida tag JNZZ42 with an assigned VIN of 1NXBR32E63Z103103 failing to maintain a single lane. As a result Corporal Simpkins conducted a well being check (Tired, ill, or impaired) of the subject. While Corporal Simpkins was in contact with defendant, he observed multiple indicators of impairment from her. While in direct contact with the defendant, I observed her to have bloodshot watery/glassy eyes, she had slurred speech, she was slightly unsteady on her feet and I smelled the strong odor of an alcoholic beverage emitting from her breath. The defendant refused to participate in the field sobriety exercises. After taking the totality of the circumstances and the defendant's indicators of impairment into consideration she was placed under arrest for DUI. The defendant was transported to Central Breath Testing and she refused to provide two lawful breath samples. As a result, she was read Implied Consent and she continued to refuse by stating "I am not taking the breath sample." I further identified the defendant via her Florida' Driver's License
