The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On listed date and time the defendant was operating a grey Chrysler four door bearing FL tag #PYDB84. The vehicle was traveling north on Collins St when Affiant observed it cross the center lane divider three separate times failing to maintain its lane of travel. A traffic stop was conducted at the listed location where contact was made with the defendant/driver. The defendant had watery eyes and fumbling fingers while trying to locate registration paperwork. Based on observations of driving pattern and during the stop, the defendant was requested to exit the vehicle. The defendant was observed to be unsteady on her feet and often times having to raise her arms to steady herself. Once out of the vehicle the distinct odor of alcoholic beverage was observed coming from the defendant's person. The defendant was requested to complete Standardized Field Sobriety Exercises which she was unable to do successfully. The defendant was placed under arrest and into the back of a marked patrol vehicle. The defendant was transported to Orient Road Jail Central Breath Testing where she refused to provide samples of her breath to determine her breath alcohol content. The defendant was read Implied Consent and still refused to provide breath samples. The defendant has a previous refusal.
