 On the above listed date and time, at the above listed location, Deputy T Alloway (ABN 252505) made contact with the defendant while conducting a traffic crash investigation (HCSO: 22- 56219, DHSMV: 24628494), where the defendant caused the crash with approximately \$7,500 in property damage. While in contact with the defendant, Deputy Alloway observed several signs of impairment. The listed victim identified the defendant, as the person operating the vehicle at the time of the crash. Deputy Alloway also observed the defendant seated in the drivers seat of the vehicle, with the vehicle on and the gear shifter in the park position upon arriving on scene. Upon the affiant making contact with the defendant, I observed several indicators of impairment to include bloodshot, watery eyes, extremely slurred speech, and the odor of an alcoholic beverage on her breath. The defendant refused the opportunity to perform Standardized Field Sobriety Exercises after being explained the consequences. The defendant refused to provide a lawful breath sample after Implied Consent warning was read and understood. The defendant was identified by her Florida driver license.
